What's new?

2023 has seen several enhancements to Intelicode and some of those changes have prompted some questions:

- Changes to the Office or Other Outpatient service type have created some confusion because options appear to be missing. This was an

intentional change to remove redundant elements. As seen in section 1 of the screenshot below, you will notice that Patient Status gives the option to select New or Established. Section 2 used to include New and Established Service Type options, but that made it necessary to enter the same information in two places. The patient status now only needs to be entered in the Patient Status section.

- Many codes were changed in 2023 to require "a medically appropriate history and/or examination" instead of specific history and exam levels. That requirement is being tracked via the question in Section 3 of the screenshot. These services will have a "History and/or Exam" tab, which includes a question that be answered Yes to get a code. This has affected Office or Other Outpatient visits as well as other services that used to have specific history/exam requirements.
