## **New Reporting Options**

- The AMA Medical Decision-Making sub-levels (Problems, Data, and Risk) can be included in the report columns for Audit Summary, Custom Provider Accuracy, and Productivity reports.
- Modifier accuracy statistics can be displayed on Audit Summary, Custom Provider Accuracy, and Productivity reports.
- A setting has been added to display status in service type names for services that use different codes for new and established patients, like Office or Other Outpatient services.
  - This can be enabled by checking "Include Status in Service Type if Status Changes Codes" in the Preferences menu.

# Compare Services in InteliCurve Across Years


• The InteliCurve Reporting form now allows you to select multiple years and compare frequency lists from different years.
